## Visalia Public Cemetery Embezzlement Grows, Manager Arrested

The size of the suspected embezzlement at Visalia Public Cemetery District (VPCD) grew by nearly 400% over initial estimate. A shortfall of \$339,000 was discovered during the 2015-16 fiscal year audit, which led to the dismissal of long-time district manager Dona Shores in October 2016.

A lengthy investigation led to an amendment of the original \$339,000 estimate to a whopping \$1,200,000 in missing funds. Shores was arrested in December and is being held on felony grand theft and



money laundering.
Investigators suspect that the embezzlement took place over a five-year period from 2011-2016.
Through her attorney, Ms. Shores has denied all charges against her. A critical 2006-07 Grand Jury Report has been ref-

erenced in multiple press articles. That report accused VPCD and Shores of numerous infractions including misuse of funds The Board of Trustees maintained that there was no evidence to sustain those allegations, and has denied that these incidents are related.

Despite the missing funds, VPCD remains in a strong financial condition. The most recent financial audit shows its net position on June 30, 2017 as \$10,238,000.

# A Summary of the Duties of a Public Cemetery District, Its Board, and Trustees By Mark R. Velasquez, Esq., Jeppson & Griffin, LLP

PCA General Counsel, Mark Velasquez has provided this outline of the mandated duties and responsibilities of Public Cemeteries. Per the disclaimer, this is not meant as an exhaustive list of the duties, rights and powers afforded a cemetery district, but a summary of the primary functions.

In this summary, <u>District</u> refers to the governmental entity; the <u>Board</u> is the entity's governing body and <u>Trustees</u> are the individual members of the body.

### The District:

- The rights and powers of a public cemetery district are listed in H&S Code §9041
- 2. Must maintain cemeteries owned by the District. (H&S Code §9040)
  - Specific Maintenance requirements and standards are found in California Code of Regulation §2333.
- 3. Each district shall adopt policies and procedures, including bidding regulations, governing the purchase of supplies and equipment. (H&S Code §9044(a))
- 4. Shall not engage in the business of selling monuments or markers. (H&S Code §9052(d))
- 5. May sell accessory and replacement objects that are necessary or convenient to interments including but not limited to burial vaults, liners, and flower vases. (H&S Code §9053)
- 6. The Cortese-Knox-Hertzberg Local Government Reorganization Act governs any change of organization or reorganization of a district. (H&S Code §9007)
- 7. Employee relations are governed by the Myers-Milias-Brown Act (H&S Code §9045)
- 8. Is subject to the Public Records Act.
- 9. Claims against the District are governed by the Government Claims Act.
- 10. May withdraw its funds from control of the County Treasurer only if the strict requirements of H&S Code §9077 are met.
- 11. May establish by resolution a local revolving fund of a <u>maximum</u> of either \$1000 to pay small bills directly, or 110% of 1/12 of annual budget to pay authorized expenditures.
- 12. May levy special taxes if revenues are inadequate. (H&S Code §§9080 & 9081)
- May seek general obligation bonds for the acquisition or improvement of real property. (H&S Code §9082)
- 14. May charge fees for other services (actual cost only) and enforcing regulations. (H&S Code §9083)

#### The Board:

- 1. Must meet at least once every three months. (H&S Code §9029)
- 2. A recorded vote of a majority of the total membership of the board of trustees is required on each action. (H&S Code §9030(a))
- 3. A Board can only act by ordinance, resolution, or motion. (H&S Code §9030(b))
- 4. The board of trustees shall keep a record of all of its acts, including financial transactions. (H&S Code §9030(d))
- 5. The board of trustees shall adopt rules for its proceedings. (H&S §Code 9030(e))
- On or before August 30 of each year adopt a final budget which conforms to the accounting and budgeting procedures for special districts contained in the California Code of Regulations commencing in sections 1031.1and 1121. (H&S §Code 9070).
  - The budget must be divided into categories outlined in Section §9070, and a copy
    of the final budget must be forwarded to the County Auditor.
- 7. On or before July I of each year adopt a resolution establishing its appropriations limit and make other necessary determinations for the following fiscal year unless as of the 1977-78 fiscal year, levy an ad valorem tax on property in excess of twelve and one-half cents (\$0.125) per one hundred dollars (\$100) of assessed value.

### Alliance Update



- 8. Require annual audits, and provide financial report to the Controller. (H&S Code §9079)
- 9. Must create an endowment care fund and require payment for each internment right in an amount no less than set by H&S Code 8738. (H&S Code §9065)
- 10. Must cause the principal of the endowment care fund to be invested as required by H&S Code §9066.
- Must make sure accurate and current records of internment rights, available plots, persons interred in the cemetery. (H&S Code §9064)
- 12. Must adopt a fee schedule for internments and services, and charge a non-resident fee of at least 15%. (H&S Code §9068)
- 13. Meetings and correspondence between trustees is governed by the open meeting laws of the Ralph M. Brown Act.

#### The Trustees:

- I. Must be a voter of the District. (H&S Code §9022)
- 2. If approved by ordinance or resolution, Trustees may receive up to \$100 for attendance at each meeting, up to a maximum of four per month. (H&S Code §9031(a))
- 3. Trustees may receive their actual and necessary traveling and incidental expenses incurred while on official business other than a meeting of the board. (H&S Code §9031(c))
- 4. Determination and reimbursement of expenses is controlled by Government Code §53232.
- 5. Shall not engage in the business of selling monuments or markers. (District employees are prohibited as well) (H&S Code §9052(d))
- 6. Must represent the interests of the public as a whole, and not solely the interests of the supervisor who appointed them. (H&S Code §9022).
- 7. Must have sexual harassment prevention training within 6 months of taking office, and every two years thereafter. (Government Code §53237)
- 8. Must take ethics training every two years, file a Form 700 annually, and is subject to the rules and regulations of the Fair Political Practices Commission. (Government Code §53235)
- 9. Must place the interests of the District above their own, and not have any conflicts of interest.
- Cannot act unilaterally, except for those duties assigned to the officers of the Board by its bylaws. One trustee =
  one vote.

Disclaimer: This is only a partial list of the laws that apply to public cemetery districts and its trustees in California. A district or its trustees should contact their general counsel for any questions or opinions regarding the above.

# Districts Updating Communications in Response to Court Ruling



"district personnel and trustees should abstain from using personal email addresses for communicating district business"

In March of 2017, a significant ruling from the California Supreme Court determined that public business transmitted on private devices is subject to the California Public Records Act (CPRA). While many districts have adopted policies and procedures to avoid the potential negative impacts this ruling can create, more work needs to be done.

As a reminder, district personnel and trustees should abstain from using personal email addresses for communicating district business. This potentially subjects personal email

communication to the scrutiny of the CPRA. Text communication of district business, no matter how innocuous it may seem, should also be avoided.

Districts that utilize electronic communication internally or externally should use agency-specific email address exclusively. This serves to protect employees and trustees, as well as the district. If your district has not yet created such accounts, you should consider doing so immediately.

There are several ways to establish these accounts.

Professional email accounts that utilize your agency's domain name is the traditional method. District employees and trustees are assigned addresses that are clearly from the agency; i.e.

jdoe@cemeterydistrict.org. There are numerous lowcost solutions. If you have a website and a registered domain name, your website host can guide you through the process.

There are work-arounds if your district has not registered a domain name. It is recommended to contact a reputable technology consultant for assistance.

# Springtime Increases Flying, Crawling, Slithering Critter Hazards

As the weather becomes warmer, you will find yourself working in outdoor areas that you didn't during the winter months. Whether you're performing activities such as mowing, weed-eating, and trimming, you may find yourself face-to-face with poisonous plants, insects, spiders, and snakes. Contact with poisonous plants, bites, or stings may send you to the doctor's office or even the emergency room for a remedy.

Remember what risk management speaker Gordon Graham said 'if it is predictable it is preventable". If you can predict that there may be a poisonous plant, snake, spider or insect present then prevention is the answer, and to do that you should look and listen before you jump into an area where you may have danger lurking.

Spiders and snakes will soon be coming out of their winter dormant state and often hide where you may have occasion to work. As a matter of fact, one of our member cemetery district's recently had an employee suffer a bite from a rattlesnake. Insect and spider bites can be just as dangerous, especially if you are allergic to them. A bite or sting may cause an allergic reaction called anaphylaxis, which can be a life-threatening event and should be treated immediately. Call 911 if you are having a reaction to a bite or sting.

### Bees, Wasps, Yellow Jackets:

- Stings kill more people each year than all other venomous animals combined.
- Look out for hives
- Keep food and drinks in your vehicle. Bees are attracted to sweet smells.
- Watch for unusual reactions to stings. Call 911 immediately!





### Spiders:


- Black widow spider venom is 15 times more poisonous than rattlesnake venom!
- Watch out for spiders when working around wood piles, vegetation and other areas that are dark.
- Wear gloves when working in areas that may harbor spiders.
- If you notice a tingling feeling, sudden nausea, or stomach pain, convulsions, or signs of shock, you may have been bitten by a spider. Seek medical attention immediately.

### Snakes:

- Rattlesnakes are the most common poisonous snake in our area and can be found
  in areas that are protected, like wood piles or rock piles, bushes or tall grass.
- Rattlesnakes are often found where there are food sources for them like gophers, squirrels, and mice.
- Other places may be near streams or rivers that have recently flooded during the winter and have transported snakes on debris piles or logs downstream and deposited them on the bank near your cemetery.
- Leave the snake alone.
- Most people are bitten trying to kill them or to get a better look.
- If a snake bite contains venom, swelling occurs quickly.
- Call 911 and seek medical assistance immediately.
- Avoid running and do not panic.
- Do not cut the affected area or attempt to remove venom with your mouth.



Report all bites, stings, and contact with poisonous plants that cause a rash or swelling to your supervisor immediately. All of these are true medical emergencies and should be treated as such. When in doubt, call 911.





In 2019, the PCA will celebrate its 25th Anniversary with a return to the Rolling Hills Casino Resort in Corning August 21-23, 2019.


